Rational for determination:

The Indiana Municipal Power Agency (IMPA) will use DOE funding under the Competitive EECBG Grant Award for activities that are bounded in compliance with the uploaded and signed NEPA Statement of Work (SOW) template. Activities under this program will include outreach, public relations, along with educational and training opportunities.

The description of project activities is described below as submitted in the EF-1:

The Indiana Municipal Power Agency (IMPA) is a wholesale electricity provider to 52 cities and towns in Indiana ("Members"). Established by state statute, IMPA and its Members are dedicated to providing reliable, environmentallyfriendly, low-cost energy to its ratepayers. Recognizing the need to encourage energy efficiency in their service areas, 20 of IMPA's Members ("Participants") joined together to invest in this Program. The Participants will replace at least 6811 street lights within their service areas with more energy efficient lighting. The Participants have also agreed to set aside fifty percent (50%) of the savings that the municipality realizes in a fund established at the local level for energy efficiency projects for a period of five years.

The federal funding will be exclusively used to purchase equipment - specifically LED lighting. The LED lighting will replace existing lighting within each of these 20 communities. The LED lighting will be retrofitted into the existing poles and structures identified by each of the Participants.

As a part of the Program, IMPA and the Participants are also committed to educating residents, businesses and industry within their respective service areas about the benefits of energy efficiency technologies. IMPA communication's team will work with each municipality on its public relation efforts to support its individual public relations strategy. IMPA will also use its ongoing public relations efforts to provide a means of direct communication to residents and decision makers in each of its Members' communities. IMPA will supply Program information to other associations with which it partners, such as the American Public Power Association and the Indiana Association of Cities and Towns. The Participants are as follows: Town of Brooklyn, City of Crawfordsville, Town of Dunreith, Town of Frankton, City of Greendale, City of Greenfield, City of Huntingburg, City of Lawrenceburg, City of Lebanon, Town of Lewisville, City of Linton, Town of Middletown, Town of Paoli, City of Rising Sun, City of Scottsburg, City of Tell City, City of Tipton, Town of Walkerton, City of Washington and Town of Winamac.

These projects comprise education and outreach, technical advice, and actions to conserve energy; therefore they are categorized under CX A9, A11, and B5.1.

Rational for determination:

The Central Basin Municipal Water District will use DOE ARRA funding for activities that are bounded in compliance with the uploaded and signed NEPA Statement of Work (SOW) template.

Project activities will consist of the purchase, implementation and installation of Irrigation Smart Controllers, which adjust according to weather and or management commands. As part of the controller installation program, pressure sensors, servers, wireless cell phones, and hydroearth controllers will be purchased and installed. Project activities also include planning, design, data analysis, education and outreach for energy and water management issues, and a review process for residential and commercial settings.

Further activities included with this project involve community outreach, program marketing and administration, and program management, water and energy audits, and data monitoring. Free showerheads and aerators will also be provided to customers as part of the review process.

The purchase, implementation and installation of irrigation smart controllers, pressure sensors, servers, wireless cell phones, and hydroearth controllers do not fall within the bounded categories of the SOW. Also, the distribution of showerheads and aerators do not fall within the bounded categories of the SOW. However, these activities do not present a significant impact to human health and/or environment. Therefore, all project activities listed above are categorically excluded under CX A1, A9, A11, and B5.1 from further NEPA review.
