<u>Proposed Action</u>: Provision of funds to the Idaho Department of Fish and Game for Purchase of Clark Fork River Delta (White Island) Property

Fish and Wildlife Project No.: 1992-061-00, Contract # BPA-004991

## Categorical Exclusion Applied (from Subpart D, 10 C.F.R. Part 1021):

**B1.25** Transfer, lease, disposition or acquisition of interests in uncontaininated land for habitat preservation or wildlife management, and only associated buildings that support these purposes. Uncontaminated means that there would be no potential for release of substances at a level, or in a form, that would pose a threat to public heath or the environment.

**Location:** Township 55 North, Range 2 East, Sections 5, and 8 of the Clark Fork USGS 7.5' quadrangle in Bonner County, Idaho (near Clark Fork, Idaho).

**Proposed by:** Bonneville Power Administration (BPA) and the Idaho Department of Fish and Game (IDFG)

Description of the Proposed Action: BPA proposes to fund the acquisition of the 131.58-acre White Island property by the IDFG. BPA will be granted a perpetual conservation easement over the entire property as a condition of funding the acquisition. The property is being acquired because of its outstanding riparian and floodplain natural resource values. The acquisition provides an opportunity to enhance, restore, and manage high quality wildlife habitat for breeding and migrating populations of bald eagle; other migratory and resident waterfowl including Canada goose, mallard duck, and redhead duck, muskrate, white-tailed deer, song birds such as the black-capped chickadee and the yellow warbler; and other species dependent on riparian habitat for their survival. The easement will protect the conservation values for which the property is being acquired by restricting activity such as residential, non-agricultural commercial and industrial development.

BPA is funding IDFG's acquisition of the property and receiving a conservation easement. Prior to any management activities, BPA will conduct further environmental review.

**Findings:** BPA has determined that the proposed action complies with Section 1021.410 and Appendix B of Subpart D of the Department of Energy's (DOE) National Environmental Policy Act (NEPA) Regulations (57 FR 15144, Apr. 24, 1992, as amended at 61 FR 36221-36243, July 9, 1996; 61 FR 64608, Dec. 6, 1996). The proposed action does not present any

extraordinary circumstances that may affect the significance of the environmental effects of the proposal. The proposal is not connected [40 C.F.R. 1508.25(a)(1)] to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts [40 C.F.R. 1508.25(a)(2)], and is not precluded by 40 C.F.R. 1506.1 or 10 C.F.R. 1021.211. Moreover, the proposed action would not (i) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, (ii) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities, (iii) disturb hazardous substances, pollutants, contaminants, or Comprehensive Environmental Response, Compensation and Liability Act-excluded petroleum and natural gas products that pre-exist in the environment such that there would be uncontrolled or unpermitted releases, or (iv) adversely affect environmentally sensitive resources.

Based on the provision that a cultural resource survey will be conducted prior to any ground disturbing activities, this proposed action meets the requirements for the Categorical Exclusion referenced above. We therefore determine that the proposed action may be categorically excluded from further NEPA review and documentation.
