Description:

B5.1 Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.

Rational for determination:

Summit County of Ohio proposes to use federal EECBG funds to replace the flat asphalt roof and associated underlying insulation on the County Department of Environmental Services Maintenance Division building. The roofing will be replaced with white Thermoplastic Olefin or Polyolefin material in order to reduce energy demands. The installation of this material will not alter the shape or visibility of the roof.

This activity has been met the requirement of the programmatic agreement between the Department of Energy and the State of Ohio for EECBG funds. This project is exempt from NHPA review through provision III. A, and appendix B 3(h) of the programmatic agreement.

This project is comprised of installation of a new roofing material; therefore a CX B5.1 will apply.
