Description:

B5.1 Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.

Rational for determination:

This is an extension of a project that was previously CX'd for the Town of Irmo in Richland County, South Carolina. The original project involved the design, engineering, and construction of a 1,065-foot long concrete pedestrian sidewalk which met SCDOT and ADA standards, and was built to provide uninterrupted pedestrian access to commercial areas from residential areas.

The original project came in under budget so the recipient proposed to install more sidewalk within the same area and using the same methods that were previously CX'd in the original project review.

The new proposed sidewalk is in the same neighborhood as the original sidewalk, and would extend the end of the original sidewalk down another two blocks, or 1034 linear feet. This addition would be constructed in the same manner as the previously approved sidewalk, and would adhere to the same conditions imposed on the original.

Based on a review of the origininally CX'd project, proposed location of additional sidewalk, and environmental information/aerial photos, this project is categorically excluded from further NEPA review under CX number B5.1, Actions to Conserve Energy.
