## Rational for determination:

The City of St. Petersburg proposes to add an additional location to the original NEPA determination (GFO-10-070) for Photovoltaic installation and the addition of an educational component associated with the PV installation.

This project will include partnering with an educational facility to develop an educational curriculum of EERE technology, installing an educational kiosk, and additional installation of PV.

A kiosk will be implemented to provide the public with the benefits of alternative energy and will be located in an existing building.

The new location of PV installation will be either on the roof or grounds of the Science Center of Pinellas. Until there is a confirmed location of the installation for the PV a NEPA hold will be placed on the project and an additional EF1 will be required upon selection of a site.

This project is comprised of developing an educational program for solar energy; therefore a CX A9 will apply.

## NEPA PROVISION

DOE has made a conditional NEPA determination for this award, and funding for certain tasks under this award is contingent upon the final NEPA determination.
