Description:

## Rational for determination:

This NEPA determination applies to an additional location for a mock roof installation associated with Hudson Valley Community College Northeast Photovoltaic Regional Training Provider project. The original NEPA review (GFO-10-237) applied to Phase 1 of this project. This additional location is part of Phase 1.

Hudson Valley Community College's sub-recipient Greenfield Community College proposes to use federal funding to install a ground mounted "mock-roofing system" to support a solar PV educational program. This project is will be located at Franklin County Technical High School, 82 Industrial Blvd., Turners Falls, MA, 01376.

This proposed site is on the northeast portion of the Greenfield Community College campus next to a greenhouse/headhouse, behind the main high school building. This project will require minor site excavations and trenching to the headhouse for electrical conduit. This mock roof system will be 4 kW, and will have PV periodically installed and removed as a learning tool. The site has been graded to level as part of the construction of the school, parking area, and greenhouse & headhouse buildings.
