- A9 Information gathering (including, but not limited to, literature surveys, inventories, audits), data analysis (including computer modeling), document preparation (such as conceptual design or feasibility studies, analytical energy supply and demand studies), and dissemination (including, but not limited to, document mailings, publication, and distribution; and classroom training and informational programs), but not including site characterization or environmental monitoring.

Activities covered include, but are not limited to, site characterization and environmental monitoring under CERCLA and RCRA. Specific activities include, but are not limited to:

### Rational for determination:

The Oregon Department of Transportation proposes to use federal funding to identify "shovel-ready" sites for installation of solar infrastructure along the highways. The solar infrastructure would be used to power signage and warning lights. Project funds (federal and cost-share) would be used to complete site-specific feasibility studies, development of sustainability concepts, public outreach and education, and identifying and obtaining required permits. Project funds will not be used t complete final design, purchase equipment, or for the installation of solar infrastructure.

The scope of the feasibility studies includes environmental baseline studies such as threatened and endangered species and biological surveys, wetlands delineations, stormwater compliance, tree mitigation and subsurface soil stability investigations. Environmental baselining studies would be completed within existing road right-of-ways which have been previously disturbed for construction of the road and drainage ditches.

Feasibility studies have begun at two sites: West Linn and Baldock. Project funds would be used to pay for feasibility studies but not for equipment, site preparation or installation of solar infrastructure.

All sites selected for installation will be subject to additional NEPA review by the Federal Highway Administration. This NEPA determination does not apply to final design, equipment, site preparation or installation of solar infrastructure.

This project entails information gathering, public outreach and education, feasibility studies, and onsite monitoring of environmental parameters; therefore a CX A9 & B3.1 apply.
