Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Order 451.1A), I have made the following determination:

## CX, EA, EIS APPENDIX AND NUMBER:

Description:

B5.1 Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.

## Rational for determination:

The Town of Jonesborough is proposing to use EECBG funding to install a ground source heat pump system that will serve the heating and cooling needs for the Booker T. Washington Arts and Interpretive Center. The ground source heat pump system will be a horizontal closed loop system with a capacity of 15 tons. The piping system will be installed about five (5) feet deep, and the soil excavated will be immediately used to backfill the ditches. The site is a gentle slope, and construction silt fence will be used to contain sediment. The ditches will be cut with the pipe installation contractor present, and immediately backfilled when piping is installed. The disturbed area will be immediately re-sown in lawn grass.

The proposed horizontal loop will be installed in an open grassy area which is cut and maintained regularly and was previously disturbed during construction of the school. The proposed project location is surrounded by areas of developed commercial and residential property. The SHPO consultation for the project will follow the guidelines set forth in the Programmatic Agreement. There are not expected to be any adverse effects to threatened and endangered species, wetlands, floodplains, or cultural resources as a result of the proposed project as these resources are not present at the project site.

After a thorough review of the information submitted for the proposed project, it has been determined that the actions involved will not have a significant impact to human health and /or the environment. The proposed project will result in a reduction in the use of conventional fossil fuels; therefore it is hereby Categorically Excluded B5.1 "actions to conserve energy," from further NEPA review.
