Description:

B5.1 Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.

#### Rational for determination:

Lake County Florida proposes to use \$40,000.00 in EECBG funding to install video cameras at 4 signal locations along US 27. Also, 1 camera will be installed at US 192 & Town Center Blvd and 200 feet of fiber optic cable will be installed to the County Fire Station. Cable will be installed using directional boring under US 27 and in the stretch to the County Fire Station. These installations are aimed at reducing energy costs of driving to the far reaches of the county to monitor the highway; saving fuels and reducing emissions by reducing idling and backed-up traffic; and enabling Lake County to better synchronize traffic.

The installation of the cable will be directionally bored and not trenched within the existing road right-of-way. This area has been graded to level and shaped for the US highway system, therefore cultural resources will not be adversely affected by the installation of the cable. The installation of the cameras will not be located in any historic district. The county fire station is less than 50 yrs and thus not eligible for listing on the National Register of Historic Places. The camera installations will not adversely affect historic structures.

The installation of the cameras and cable will not negatively impact any floodplain; take threatened or endangered species and/or critical habitat; and will not impact wetlands.

This project is comprised of installation of cameras to conserve energy; therefore a CX B5.1 will apply.
