Proposed Action or Project Description:

Tamarisk proliferation has compromised species diversity, contributed to salinity and sedimentation problems, and reduced water availability for other plants and aquatic life. Multiple agencies and private groups have developed a comprehensive program to eradicate it and other invasive species along the Dolores River between McPhee Dam and the Colorado River.

DOE proposes to allow Gold Eagle Mining, Inc., (GEMI) to exchange royalties due on three lease tracts for in-kind service. Employees of or contractors to GEMI would remove tamarisk and other invasive species along a 3.5-mile segment of the Dolores River that traverses one of their lease tracts. Mechanical (e.g., shears) or manual means (e.g., chain saws or brush clippers) would be used to either remove branches or stems of trees or to remove entire trees. Other nonnative invasive species would also be targeted for removal. Immediately after branches or stems of the tamarisk are cut, a Colorado-licensed pesticide applicator would use hand application methods to treat the cut surfaces. Disturbed areas would be reclaimed and seeded with a mixture approved by the U.S. Bureau of Land Management (BLM) for use along the Dolores River.

Removing the tamarisk and other invasive species would improve habitat for listed and sensitive fish species potentially present in the Dolores River, which is a tributary to the Colorado River.

Short-term and minor impacts associated with these activities would include fugitive dust generation, elevated noise levels, and surface disturbance.

Categorical Exclusion(s) Applied:

B1.20: Small-scale activities undertaken to protect, restore, or improve fish and wildlife habitat.

B1.3 (k): Erosion control and soil stabilization measures (such as reseeding and revegetation).
