Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Order 451.1A), I have made the following determination:

CX, EA, EIS APPENDIX AND NUMBER:

Description:

B5.1 Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.

Rational for determination:

The County of Fairfax in Virginia is proposing to use \$60,000 in DOE EECBG funding to purchase and install 10 electric vehicle charging stations at County building parking lots and maintenance facilities to support its plug-in electric vehicle (PEV) fleet. The 10 stations would all be Level 2 charging stations that would provide a nominal 240V 30A charging service.

Proposed locations for these stations would be on Fairfax County properties located either in existing paved parking lots adjacent to the County facilities or paved areas adjacent to current maintenance facilities. Photos of all proposed locations have been provided to DOE and are uploaded into the PMC.


