Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Order 451.1A), I have made the following determination:

CX, EA, EIS APPENDIX AND NUMBER:

Description:

B5.1 Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.

Rational for determination:

This NEPA determination (EE0000133) is a result of a previous NEPA determination (GFO-09-332-003). OK's Department of Commerce would pass DOE share funding to the Public Service Company of Oklahoma ("PSO"). PSO would use DOE funding for a revolving loan fund, which could fund installation of 10,000 gridSMART meters in the Tulsa area. The gridSMART meters would be same size as the existing meters and will fit into the existing meter box at or on the facility. There would be no additional wiring needed for installation of the gridSMART meters.

This determination covers the following addition in scope that is the result of a lower goods/services price than originally planned for:

Installation of approximately 800 Smart Meters in Student Housing at the University of Tulsa in the city of Tulsa, OK

Installation of approximately 800 Smart Meters in low-income housing units in the city of Burns Flat, OK

These areas were selected because they are considered unique and diverse populations which would make resulting energy usage data more robust.

In the performance of work in all program areas, grantees would be required to comply with all applicable federal, state and local laws, regulations and standards, including but not limited to the handling, storage, transportation and disposal of waste. If a grantee proposes work that may affect an historic property or archaeological resource listed in or determined to be eligible for the National Register of Historic Places, the grantee would be required to comply with the requirements of Section 106 of the National Historic Preservation Act.

Note: There is no DOE funding amount associated with this determination due to the nature of the action, which is to increase the number of Smart Meter installations compared to the number originally tasked. The no-cost aspect results from residual funds that accrued due to lower Smart Meter unit prices than originally budgeted.

This project comprises actions to conserve energy; therefore it is categorized under CX B5.1.
