RECORD OF CATEGORICAL EXCLUSION DETERMINATION

A. Proposed Action: Western was asked by Pacificorp to do geologic boring within our right-of-way at Glen Canyon Communication Site for a Bureau of Reclamation project that involves replacing a communication tower and control building. This project involves accessing the borehole location with an auger/drill rig and light crew trucks, setting up the drilling, drilling, collecting soil samples and breaking down the drilling setup. Pacificorp will be using existing access roads and vehicles such as pickup trucks, crew trucks, backhoes and bucket trucks to bring personnel and equipment to the work areas.

The attached maps show the project areas situated within Section 25 Township 41 North Range 8 East on the Gila & Salt River Baseline and Meridian, Coconino County, Arizona. The corresponding U.S.G.S. 7.5-minute topographic map is Page, Arizona. This work is planned to begin in November of 2011.

B. Categorical Exclusion Applied: 10 CFR, Part 1021, Subpart D, Appendix B,B3.1: "Onsite and offsite characterization and environmental monitoring, including siting, construction (or modification), operation, and dismantlement or closing (abandonment) of characterization and monitoring devices and siting, construction, and associated operation of a small scale laboratory building or renovation of a room in an existing building for sample analysis. Activities covered include but are not limited to site characterization and environmental monitoring under CERCLA and RCRA. Specific activities include but are not limited to:...(f) Sampling and characterization of water, soil, rock or contaminants..."

C. Regulatory Requirements in 10 CFR 1021.410 (b):

- 1. The proposed action fits within a class of actions that is listed in Appendix B to Subpart D.
 - a. The proposed action was reviewed for the requirements of the Endangered Species Act, the National Environmental Policy Act (NEPA), the National Historic Preservation Act, and all applicable Department of Energy Orders.

- 3. The proposal is not "connected" to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.
- D. <u>Determination</u>: Based on my review of information conveyed to me and in my possession (or attached) concerning the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1A), I have determined that the proposed action fits within the specified class of actions, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
