**Proposed Action:** In-kind wood pole replacements as needed on the Driscoll-Naselle No. 1 115-kV transmission line right-of-way (ROW)

**PP&A Project No.:** 2252, WO# 00298137

<u>Categorical Exclusion Applied (from Subpart D, 10 C.F.R. Part 1021)</u>: B1.3 Routine maintenance activities.

<u>Location</u>: Wahkiakum County, Washington, in Bonneville Power Administration's (BPA) Chehalis District

**Proposed by:** BPA

<u>Description of the Proposed Action</u>: BPA proposes to replace deteriorating wood poles and associated structural/electrical components (e.g. crossarms, insulators, and guy anchors) at existing H-frame structures along the subject transmission line. Wood pole replacements would be in-kind and would utilize the existing holes to minimize ground disturbance. If necessary, an auger would be used to remove any loose soil from the existing hole prior to new wood pole replacement. Two wood pole structures have been identified for replacement in 2012.

The transmission line ROW corridor crosses Wahkiakum County and privately-owned land that includes rural residential property and industrial forestlands, with generally level terrain. There is adequate, existing access to all of the structures along this transmission line corridor and no access road work or landing construction is anticipated at any location. The proposed action is required to maintain safe and reliable power transmission in the region.

**Findings:** BPA has determined that the proposed action complies with Section 1021.410 and Appendix B of Subpart D of the Department of Energy's (DOE) National Environmental Policy Act (NEPA) Regulations (57 FR 15144, Apr. 24, 1992, as amended at 61 FR 36221-36243, July 9, 1996; 61 FR 64608, Dec. 6, 1996, 76 FR 63764, Nov. 14, 2011). The proposed action does not present any extraordinary circumstances that may affect the significance of the environmental effects of the proposal. The proposal is not connected [40 C.F.R. 1508.25(a)(1)] to other actions with potentially significant impacts, has not been segmented to meet the definition of a categorical exclusion, is not related to other proposed actions with cumulatively significant impacts [40 C.F.R. 1508.25(a)(2)], and is not precluded by 40 C.F.R. 1506.1 or 10 C.F.R. 1021.211. Moreover, the proposed action would <u>not</u> (i) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health,

(ii) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities, (iii) disturb hazardous substances, pollutants, contaminants, or Comprehensive Environmental Response, Compensation and Liability Act-excluded petroleum and natural gas products that pre-exist in the environment such that there would be uncontrolled or unpermitted releases, (iv) have the potential to cause significant impacts on environmentally sensitive resources, or (v) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements.

This proposed action meets the requirements for the Categorical Exclusion referenced above. We therefore determine that the proposed action may be categorically excluded from further NEPA review and documentation.
