Rational for determination:

This NEPA determination applies to the Solar Energy Evolution and Diffusion Studies (SEEDS) Funding Opportunity Announcement (FOA) (GFO-FOA0740-001). The SEEDS program would be administered through DOE's SunShot Initiative.

The purpose of the SEEDS FOA is to launch a series of systematic investigations into the solar industry with the goal of improving the operations of solar researchers, manufacturers, developers, installers and policymakers. After issuing the FOA, DOE would select applications for negotiation of financial assistance. Selected research efforts would be conducted in conjunction with industry practitioners.

All of the activities that would be completed, using DOE and cost-share funding, under the financial assistance agreements would be administrative in nature including information gathering, data analysis and dissemination. CX A9 applies to all awards selected through the SEEDS FOA.

In the event that DOE selects an application that proposes activities not covered by this NEPA determination (i.e. activities that are not limited to information and data analysis - including laboratory-scale research) additional NEPA review will be completed prior to award.
