Description:

A9 Information gathering, analysis, and dissemination Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. A11 Technical advice and assistance to organizations Technical advice and planning assistance to international, national, state, and local organizations.

Rational for determination:

The U.S. Department of Energy (DOE) provided \$528,000 of federal funding to the State of Washington under the DOE's Annually Appropriated State Energy Program (SEP) for 2012. Washington will match the federal funding with \$511,970 in state funds, for a total of \$1,039,790.

Washington proposes to fund the following Market Titles:

Energy Library:

Under this Market Title, Washington State University (WSU) Extension Energy Library would provide energy information services and materials to target audiences through their website. Target audiences include WSU faculty, staff and students, State energy staff, government agencies, energy professionals, utilities, residents of Washington and other libraries.

Energy Policy:

Under this Market Title, funding would be utilized to report on energy consumption and price statistics, conduct state and regional energy planning, develop a post-ARRA SEP plan, develop policy and energy legislation recommendations, promote bioenergy and develop recommendations for transportation alternatives.

Resource Conservation Manager:

Under this Market Title, funding would be used to provide program and technical support for existing Resource Conservation Managers, who focus on resource and operational efficiency, and promote the creation of new positions. Activities would focus on development of a monthly email newsletter, online guidebook, and support via telephone or email.

Based on a review of the activities that would be funded under the above Market Titles, DOE has determined the projects that would be funded under these Market Titles will not significantly impact the human environment and they are categorically excluded from further NEPA review under CX A9 "information gathering," and CX A11 "technical advice."


