Rational for determination:

The U.S. Department of Energy (DOE) provided funding to the City of El Paso, Texas under the DOE's American Recovery and Reinvestment Act of 2009 Energy Efficiency and Conservation Block Grant Program (EECBG). El Paso proposes to use \$200,000 to install a gazebo with solar photovoltaic panels.

The proposed project would install a 900 watt solar photovoltaic system onto a newly constructed park gazebo. The gazebo would provide outlets marked for use by residents. The project would be constructed in a new pocket park to be located at the cross streets of N. Santa Fe St. and Missouri, adjacent to the El Paso Museum of History 510 N. Santa Fe St., El Paso, Texas 79901. The park would be located in a commercial area near other city and office buildings including City Hall.

The proposed project would excavate one foot deep for concrete footings for the structure. The project would not require any new trenching for electrical wiring; the electricity would be used directly in the gazebo. The project would be utilized as a renewable energy demonstration and for educational purposes. The park would have signs on the north and south sides of the pavilion providing information about how solar photovoltaics operate and other installations in the City.

The proposed project would not have adverse effects on threatened and endangered species, wetlands, floodplains, or cultural resources, as these resources are not known to occur at the proposed sites. SHPO provided a determination of no adverse effect to historic properties dated 11-30-2011.

Based on review of project information and the above analysis, DOE has determined that the installation of the proposed solar photovoltaic system would not have a significant individual or cumulative impact to human health and/or environment. DOE has determined the proposed charging station is consistent with the actions contained in DOE categorical exclusion A9 "information gathering, analysis, and dissemination," B3.14 "small-scale educational facilities," and B5.16 "solar photovoltaic systems" and is categorically excluded from further NEPA review.
