### Line Switch Replacements at Chappell and Julesburg Taps in Deuel County, Nebraska and Kersey Tap in Weld, Colorado

A. <u>Brief Description of Proposal</u>: Western Area Power Administration (Western) proposes to replace the wood switch structures and 115-kilovolt (kV) line disconnect switches with new switches and steel box structures at the Chappell and Julesburg Taps in Deuel County, Nebraska, and the Kersey Tap in Weld County, Colorado. All line disconnect switches are mounted on four wood pole structures with similar configurations. Many of the switches and structures were installed in the early 1950's, are original, obsolete, and difficult to find replacement parts. The mounting wood structures are deteriorating and have been rejected and require replacement. Western's proposed action would occur entirely within the fenced perimeter of each Tap. Western proposes the following at each location:

### Chappell Tap

On the Big Springs Station to Sidney 115-kV transmission line, Western will remove line disconnect switches 2860, 2861, 2865, and 2870 and the four pole wood structures, and replace them with new switches mounted onto a new steel box structure.

#### **Julesburg** Tap

On the Big Springs Station to Sidney 115-kV transmission line, Western will remove line disconnect switches 3860, 3861, 3863, 3865, and 3870 and the four pole wood structures, and replace them with new switches mounted onto a new steel box structure.

#### Kersey Tap

On the Kiowa Creek to Weld 115-kV transmission line, Western will remove line disconnect switches 2160, 2161, 2165, and 2170 and the four pole wood structures, and replace them with new switches mounted onto a new steel box structure.

#### **B4.6 Additions and modifications to transmission facilities.**

Additions or modifications to electric power transmission facilities within a previously disturbed or developed facility area. Covered activities include, but are not limited to, switchyard rock grounding upgrades, secondary containment projects, paving projects, seismic upgrading, tower modifications, load-shaping projects (such as the installation and use of flywheels and battery arrays), changing insulators, and replacement of poles, circuit breakers, conductors, transformers, and crossarms.

#### **B4.11 Electric power substations and interconnection facilities**

Construction or modification of **electric power substations** or interconnection facilities (including, but not limited to, **switching stations** and support facilities)

- C. <u>Regulatory Requirements in 10 CFR 1021.410 (b)</u>: (See full text in regulation and attached checklist.)
  - 1) The proposed action fits within a class of actions listed in Appendix A or B to Subpart D.

For classes of actions listed in Appendix B, the following conditions are integral elements. To fit within a class, the proposal <u>must not</u>:

- Threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders;
- Require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities;
- Disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases;
- Have the potential to cause significant impacts on environmentally sensitive resources. An environmentally sensitive resource is typically a resource that has been identified as needing protection through Executive Order, statute, or regulation by Federal, State, or local government, or a federally recognized Indian tribe. An action may be categorically excluded if, although sensitive resources are present, the action would not have the potential to cause significant impacts on those resources (such as construction of a building with its foundation well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). Environmentally sensitive resources include, but are not limited to; those listed in paragraph B. (4) (see Attachment A).
- 2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
- 3) The proposal is not "connected" to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

### D. Special Stipulations Pertaining to the Proposal:

If the scope of work of this project changes, Western's Environmental Division must be contacted for additional environmental review.

This Categorical Exclusion is valid only from signature date through the end of calendar year 2013. If construction has not commenced within that time, Western's Environmental Division must be contacted for an updated environmental review prior to construction.

The findings of this Categorical Exclusion depend on the contractor's execution of, or compliance with, Western's construction specifications for the project, specifically, Division 13 – Environmental Quality Protection.

If any cultural materials are discovered during construction, work in the area shall halt immediately and Western's Environmental staff shall be contacted.
