Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. **Rational for determination:**

The U.S. Department of Energy (DOE) is proposing to provide federal funding to the Northeast Energy Efficiency Partnerships, Inc. (NEEP) to provide regional support and technical assistance for DOE Energy Efficiency and Renewable Energy (EERE) programs.

NEEP would support the EERE program areas of Advanced Manufacturing Office, Building Technologies Program, Office of Strategic Programs and Weatherization and Intergovernmental Programs. NEEP would utilize funding to collect best practices, case studies and data to provide the impact of EERE funds, provide technical assistance and training to public and private groups, analyze and revise policies, organize meetings, conferences and events, and prepare educational and outreach documents and webpages.

Based on review of the project information and the above analysis, DOE has determined the activities would not have a significant individual or cumulative impact to human health and/or environment. DOE has determined the proposed project is consistent with the actions contained in DOE categorical exclusion A9 "information gathering, analysis, and dissemination," and A11 "technical advice and assistance," and is categorically excluded from further NEPA review.


