A. <u>Brief Description of Proposal</u>: Western Area Power Administration (Western) proposes to conduct routine maintenance activities by installing an asphalt slurry overlay on the parking lots and roadways at Western's Montrose Operations Center in Montrose, Colorado. The slurry seal involves the creation of a mixture of asphalt emulsion and fine crushed aggregate that is spread on the surface of a road. Existing asphalt surfaces would be cleaned to make it free of loose material, dirt, dust, and debris. A tack coat would be applied followed with a ¼ inch asphalt slurry seal coat. The final step would be painting pavement markings.

Areas to receive the asphalt overlay:

- Visitor parking and associated drives located on the east side of the Administration building.
- Driveway along southern property line, the employee parking and associated drives located on the west side of the Administration building.
- All asphalt located around the warehouse, shops, and garage buildings on the west side of the Administration building including the loading docks, etc.

The area in the northwest corner of the site is to be excluded from the overlay process.

B. Number and Title of the Categorical Exclusion Being Applied: (See text in 10 CFR Part 1021, Subpart D.)

B1.3 Routine Maintenance.

Routine maintenance activities and custodial services for buildings, structures, rights-of-way, infrastructures (including, but not limited to, pathways, roads, and railroads), vehicles and equipment, and localized vegetation and pest control, during which operations may be suspended and resumed, provided that the activities would be conducted in a manner in accordance with applicable requirements. Custodial services are activities to preserve facility appearance, working conditions, and sanitation (such as cleaning, window washing, lawn mowing, trash collection, painting, and snow removal). Routine maintenance activities, corrective (that is, repair), preventive, and predictive, are required to maintain and preserve buildings, structures, infrastructures, and equipment in a condition suitable for a facility to be used for its designated purpose. Such maintenance may occur as a result of severe weather (such as hurricanes, floods, and tornados), wildfires, and other such events. Routine maintenance may result in replacement to the extent that replacement is in kind and is not a substantial upgrade or improvement. In kind replacement includes installation of new components to replace outmoded components if the replacement does not result in a significant change in the expected useful life, design capacity, or function of the facility. Routine maintenance does not include replacement of a major component that significantly extends the originally intended useful life of a facility (for example, it does not include the replacement of a reactor vessel near the end of its useful life). Routine maintenance activities include, but are not limited to:

- a. Repair of facility equipment, such as lathes, mills, pumps, and presses;
- b. Door and window repair or replacement;
- c. Wall, ceiling, or floor repair;
- d. Reroofing;
- e. Plumbing, electrical utility, and telephone service repair or replacement;
- f. Routine replacement of high-efficiency particulate air filters;
- g. Inspection and/or treatment of currently installed utility poles;
- h. Repair of road embankments;
- i. Repair or replacement of fire protection sprinkler systems;
- j. Road and parking area resurfacing, including construction of temporary access to facilitate resurfacing, and scraping and grading of unpaved surfaces;
- k. Erosion control and soil stabilization measures (such as reseeding, gabions, grading, and revegetation);
- 1. Surveillance and maintenance of surplus facilities in accordance with DOE Order 435.1, "Radioactive Waste Management' or its successor;
- m. Repair and maintenance of transmission facilities, such as replacement of conductors of the same nominal voltage, poles, circuit breakers, transformers, capacitors, crossarms, insulators, and downed powerlines, in accordance, where appropriate, with 40 CFR part 761 (Polychlorinated Biphenyls Manufacturing, Processing, Distribution in Commerce, and Use Prohibitions) or its successor;
- n. Routine testing and calibration of facility components, subsystems, or portable equipment (such as control valves, in-core monitoring devices, transformers, capacitors, monitoring wells, lysimeters, weather stations, and flumes);
- o. Routine decontamination of the surfaces of equipment, rooms, hot cells, or other interior surfaces of buildings (by such activities as wiping with rags, using strippable latex, and minor vacuuming) and removal of contaminated intact equipment and other material (not including spent nuclear fuel or special nuclear material in nuclear reactors); and
- p. Removal of debris.

C. <u>Regulatory Requirements in 10 CFR 1021.410 (b)</u>: (See full text in regulation and attached checklist.)

1) The proposed action fits within a class of actions listed in Appendix A or B to Subpart D.

For classes of actions listed in Appendix B, the following conditions are integral elements. To fit within a class, the proposal <u>must not</u>:

- Threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders;

- 2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
- 3) The proposal is not "connected" to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

D. Special Stipulations Pertaining to the Proposal:

If the scope of work of this project changes, Western's Environmental Division must be contacted for additional environmental review.

This Categorical Exclusion is valid only from signature date through the end of calendar year 2013. If construction has not commenced within that time, Western's Environmental Division must be contacted for an updated environmental review prior to construction.

Measures shall be put in place to prevent spills of asphalt overlay materials, paints, waste water, or any other material from entering storm drains located at the Montrose Operations Center. All asphalt overlay materials, chemicals, paints, and any liquids materials, including temporary toilets,

shall be stored with secondary containment in areas away from the storm drains. Spill prevention and response measures shall be documented and in place with staff trained prior to commencement of asphalt overlay activities at the Operations Center.

E. Determination: Based on my review of information provided to me and in my possession concerning the proposed action, I determined that the proposed action fits within the specified class of actions, the other regulatory requirements set forth above are met, and the proposed action is categorically excluded from requirements for an EA or an EIS.
