Rational for determination:

The U.S. Department of Energy (DOE) provided \$453,000.00 of federal funding to the State of Connecticut Department of Energy & Environmental Protection (DEEP) under the DOE's Annually Appropriated State Energy Program (SEP) for 2012. DEEP will match the federal funding with \$496,281.53 in state funds. Additionally, DEEP will carry over "Evergreen" funds from its Recovery Act SEP financing programs under this annual SEP award. These funds are not included in the annual SEP budget but will be tracked in this award.

DEEP proposes to fund the following market titles:

Administration:

Under this Market Title, federal funding would be used for management and coordination of state, local and federal energy programs, and for various policy and legislative initiatives.

Consumer Markets:

Under this Market Title, federal funding would be used to promote energy efficiency to the general public, both residential and commercial/industrial. Energy efficiency retrofits or renewable energy projects implemented under this market title are subject to additional NEPA review.

SEP Recovery Act Financing Program:

Under this Market Title DEEP would track and report on the use of Evergreen funds. No new activities or federal funds are associated with this Market Title.

State Facilities:

Under this Market Title, federal funding would be used for promoting energy efficiency in State facilities. Examples include a database to track energy usage and costs in state buildings, training on building codes, developing policy initiatives to reduce state agency energy usage, and using benchmark results to better target funds for efficiency projects. Energy efficiency retrofits or renewable energy projects implemented under this market title are subject to additional NEPA review.

Based on a review of the activities that would be funded under the above Market Titles, DOE has determined the projects that would be funded under these Market Titles will not significantly impact the human environment and they are categorically excluded from further NEPA review under CX A9 "information gathering" and CX A11 "technical advice." Any activities funded under the 2012 annual appropriations that involve ground-breaking activities, retrofits, or equipment purchase and/or installation are conditioned pending additional NEPA review.

NEPA PROVISION

DOE has made a conditional NEPA determination for this award, and funding for certain tasks under this award is contingent upon the final NEPA determination.

Insert the following language in the award:

You are restricted from taking any action using federal funds, which would have an adverse affect on the environment or limit the choice of reasonable alternatives prior to DOE/NNSA providing either a NEPA clearance or a final NEPA decision regarding the project.

Prohibited actions include:

Any activities funded under the 2012 annual appropriations that involve ground-breaking activities, retrofits, or equipment purchase and/or installation are conditioned pending additional NEPA review.

Energy efficiency retrofits or renewable energy projects implemented under the Consumer Markets market title are subject to additional NEPA review.

Energy efficiency retrofits or renewable energy projects implemented under the State Facilities market title are subject to additional NEPA review.

This restriction does not preclude you from:

Activities that are administrative in nature, and activities under market titles that are limited to information gathering, analysis and dissemination, techincal advice and assistance.

If you move forward with activities that are not authorized for federal funding by the DOE Contracting Officer in advance of the final NEPA decision, you are doing so at risk of not receiving federal funding and such costs may not be recognized as allowable cost share.
