Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Order 451.1A), I have made the following determination:

Description:

A11 Technical advice and assistance to organizations

Technical advice and planning assistance to international, national, state, and local organizations.

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. Rational for determination:

The U.S. Department of Energy (DOE) provided \$190,000 of federal funding to the District of Columbia (DC) under the DOE's Annually Appropriated State Energy Program (SEP) for 2012. DC will provide \$41,412.90 in state match.

DC proposes to fund the following market titles:

Energy Efficiency for Government Buildings

Under this Market Title, federal funding would be used to continue an outreach and education partnership that addresses smaller-scale energy issues that contribute to energy use in government buildings. Educational workshops would be conducted for DC government employees and a series of workshops would also be conducted.

Green Purchasing, Energy

Under this Market Title, federal funding would be used to distribute the EPP policy material throughout the DC government during the energy efficiency workshops conducted in DC government facilities. Federal funding would also be used to promote the most recent passage of the Procurement Act, Section and to ensure compliance with "Green Purchasing."

Promote Alternative Fuel & Transportation

Under this Market Title, federal funding would be used to continue participation in Clean Cities Activities along with Council of Governments. The Clean Cities committee would analyze practical approaches to implementing Smart Growth which includes public transportation initiatives. The staff would continue to monitor its fleet and promote the transition to a 100% alternative fueled fleet. No federal funding would be used to purchase vehicles.

School/Community Energy Education

Under this Market Title, federal funding would be used for personnel and benefits costs associated with implementing an "Energy Patrol Program." The Energy Patrol would consist of at least ten students per school and one teachercoordinator that would be taught how to inspect their school building for energy waste. The students would inspect their school buildings daily for energy waste and recommend energy conservation measures. Approximately 25 classrooms would be enrolled in the Energy Patrol Program.

Based on a review of the activities that would be funded under the above Market Titles, DOE has determined the projects that would be funded under these Market Titles will not significantly impact the human environment and they are categorically excluded from further NEPA review under CX A9 "information gathering" and CX A11 "technical advice." Any activities funded under the 2012 annual appropriations that involve ground-breaking activities, retrofits, or equipment purchase and/or installation are conditioned pending additional NEPA review.
