A. <u>Brief Description of Proposal</u>: Western Area Power Administration (Western) proposes to approve a new point of delivery request and the delivery of approximately 17 Megawatts (MW) of electrical power under an existing network service agreement with Tri-State Generation and Transmission Association (Tri-State). The point of delivery would provide electric service to new loads associated with a natural gas compressor station that is being developed by DCP Midstream, LLC. This delivery point will be added to Tri-State's existing Network Integration Transmission Service (NITS) contract between Western and Tri-State, Contract No. 07 RMR-1611.

Western has agreed to the new delivery point, and proposes to construct a new switching station on the existing Kiowa Creek – Weld (KIC-WLD) 115-kV Transmission Line, near Structure No. 19/5, to be known as the Kersey West switching station. The switching station will consist of a 115-kV four-ring breaker bus including a control building and communications system. The switching station would be constructed within a fenced perimeter on approximately 7.46 acres of previously disturbed agricultural land at the southwest intersection of County Road 54 and County Road 51 near the town of Kersey in Weld County, Colorado. In accordance with existing agreements, a temporary tap along the KIC-WLD line will be installed near Structure No. 19/5. This will serve the customer load until the switching station is constructed.

B. Number and Title of the Categorical Exclusion Being Applied: (See text in 10 CFR Part 1021, Subpart D.)

B4.1 Contracts, policies, and marketing and allocation plans for electric power:

Establishment and implementation of contracts, policies, and marketing and allocation plans related to electric power acquisition that involve only the use of the existing transmission system and existing generation resources operating within their normal operating limits.

B4.11 Electric power substations and interconnection facilities:

Construction or modification of electric power substations or interconnection facilities (including, but not limited to, switching stations and support facilities).

- Disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases;
- Have the potential to cause significant impacts on environmentally sensitive resources. An environmentally sensitive resource is typically a resource that has been identified as needing protection through Executive Order, statute, or regulation by Federal, State, or local government, or a federally recognized Indian tribe. - 2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
- 3) The proposal is not "connected" to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

D. Special Stipulations Pertaining to the Proposal:

This Categorical Exclusion is valid only from signature date through the end of calendar year 2014. If construction has not commenced within that time, Western's Environmental Division must be contacted for an updated environmental review prior to construction.

If the scope of work of this project changes, Western's Environmental Division must be contacted for additional environmental review.

Western must have a professional archaeologist present during initial ground disturbing activities (to include excavation for the ground mat, etc.) in order to identify the historic irrigation pipeline that may be present within the project area. If the pipeline is located, work in the area of the discovery must stop, and the archaeologist must be allowed to assess the resource and document it if necessary. Work may resume in the area of discovery following the assessment and/or documentation.

If the construction work is to occur between March 1 and July 31, the construction contractor shall consult with Western's Environmental Division. To comply with the Migratory Bird Treaty Act, a pedestrian survey would be conducted in advance of the construction project.

The contractor shall comply with all Federal, State, and local environmental laws, orders, and regulations. All necessary permits such as National Pollutant Discharge Elimination System (NPDES) permits shall be obtained by Western's construction contractor.

While it is not often effective to prevent animals' access into substations, Western would reduce impacts by utilizing protection for buswork, circuit breakers, transformers, and capacitors. Hazard guards and insulation would be installed, as necessary.

On completion of the work, all destruction, scarring, damage, or defacing of the landscape resulting from the contractor's operations shall be repaired by the construction contractor.

E. <u>Determination</u>: Based on my review of information provided to me and in my possession concerning the proposed action, I determined that the proposed action fits within the specified class of actions, the other regulatory requirements set forth above are met, and the proposed action is categorically excluded from requirements for an EA or an EIS.
