Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Order 451.1A), I have made the following determination:

Description: B5.16 Solar The installation, modification, operation, and removal of commercially available solar photovoltaic systems photovoltaic located on a building or other structure (such as rooftop, parking lot or facility, and mounted to signage, lighting, gates, or fences), or if located on land, generally comprising less than 10 acres within a previously systems disturbed or developed area. Covered actions would be in accordance with applicable requirements (such as local land use and zoning requirements) in the proposed project area and would incorporate appropriate control technologies and best management practices.

Rational for determination:

The U.S. Department of Energy (DOE) provided federal funding to the State of Nevada Office of Energy (Nevada) under the DOE's Annually Appropriated State Energy Program (SEP) for Fiscal Year 2012. Nevada proposes to grant approximately \$21,250 of this funding to the Nevada Division of State Parks (NDSP) to implement a small-scale solar lighting project at Sand Harbor of Lake Tahoe Nevada State Park.

A previous NEPA determination for this award's Fiscal Year 2012 funding was made on 6/25/2012 (CX A9 and A11). Approvals, prohibited actions and restrictions from that NEPA determination are not affected by this NEPA determination. This NEPA determination only applies to this single NDSP small-scale solar lighting project.

DOE funding would be used to implement a small-scale solar lighting project to provide walkway lighting for a paved sidewalk at Sand Harbor of Lake Tahoe Nevada State Park located on State Route 28, three miles south of Incline Village, Nevada. Two 250 watt solar photovoltaic panels would be installed on the roof of an existing restroom building located adjacent to the Main Beach parking lot with in the park. The panels would not be grid tied and would charge batteries to power the lights at night. The batteries would be installed in a protective enclosure with the restroom building. LED walkway foot lighting fixtures would be installed along approximately 450 feet of existing sidewalk connecting the Main Beach parking lot to the Visitor's Center. Ground disturbance would occur alongside the existing paved sidewalk to trench in conduit for the lighting fixtures. All ground disturbance activities would be in previously disturbed areas of the park adjacent to the paved parking lot, restroom building and paved sidewalk.

The Nevada State Historic Preservation Office performed an archaeological inventory assessment for the proposed project location and concurred with the Federal Highway Administration's Recreational Trails Program (FHA) determination that no historic properties would be affected by this undertaking. This project was originally proposed to the FHA for funding.

DOE has determined the proposed project would not have adverse effects on threatened or endangered species, wetlands, floodplains, or cultural/historic resources, as these resources are not known to occur at the proposed project site.

Based on review of the project information and the above analysis, DOE has determined that the installation of smallscale solar lighting project at Sand Harbor of Lake Tahoe Nevada State Park would not have a significant individual or cumulative impact to human health and/or environment. DOE has determined the proposed activities are consistent with the actions contained in DOE categorical exclusions B5.16 "solar photovoltaic systems" and is categorically excluded from further NEPA review.
