Proposed Action Title: Oracle to Tucson 115-kV Transmission Line, Cross Arm Replacements at Structures 2/5 and 7/3

Program or Field Office: Western Area Power Administration, Desert Southwest Regional Office

Location(s) (City/County/State): Oracle Junction, Pinal and Pima Counties, Arizona

Proposed Action Description:

Western proposes to conduct cross arm replacements at two wood pole structures located on the existing Oracle to Tucson 115-kV transmission line in Pinal and Pima counties, Arizona. The wood poles requiring cross arm replacements are structures 2/5 and 7/3; these structures are located on Arizona State Trust lands in Township 10 South, Range 13 East, Section 4 and Township 11 South, Range 13 East, Section 1 (Gila and Salt River Baseline and Meridian). The project is about 2 miles west of the intersection of State Route (SR) 77 and SR 79. The purpose of the work is to replace wood cross arms which have become damaged or broken. The project is necessary to provide for the safe and continuous operation of the bulk electrical system. Equipment used on site will include bucket trucks, line trucks, and crew trucks (F-350s or similar). Access to the structures will be via existing roads; no access road improvements or construction will be completed for this project. No blading or grubbing is required to complete the repairs. The work will begin no sooner than May 20, 2013, and will be completed within 3 weeks.

Special Condition:

1. No construction activities will take place in the vicinity of a desert tortoise. All workers shall regularly check the project area, including beneath vehicles and equipment, for desert tortoise. At any time a desert tortoise is seen within or near any work area (including access roads, turnouts, staging areas, etc.), the project supervisor will be immediately notified and the tortoise allowed to leave the work area on its own. If a tortoise is located in imminent harm's way, Western Environmental Group (602-605-2640) will be contacted immediately. Desert tortoises may only be handled or moved by personnel as approved by Western Environmental Group.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.




