Rational for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to Cloud County Community College (Cloud) in Concordia Kansas, to develop the Wind Energy Technology Project and Renewable Energy Center of Excellence. DOE funding would be used to purchase and pay for the construction of three wind turbines already installed by Cloud and to develop educational training on Wind Energy Technology (WET). DOE funding would also be used to develop and implement a marketing plan for the Blade Repair Certificate component of Cloud's WET program, upgrade the program through state-of-the-art equipment and facility and build industry partnerships for the WET degree and certificate program.

Previous NEPA determinations have been made for this award, including and EA determination to retroactively analyze the impacts of the construction and operation of the wind turbines. This NEPA determination applies to Tasks 1, 4, 5, 6, 7, and 9. Tasks 2, 3, and 8 are conditioned upon the completion of the ongoing EA.
