- A. <u>Brief Description of Proposal</u>: Western Area Power Administration (Western) proposes the upgrade and replacement of the 230/138/13.8-kV transformer KZ2A, at Western's Hayden Substation located approximately 4 miles east of Hayden, Colorado. The existing transformer has a 150 MVA capacity. The new transformer will have a 250 MVA capacity. A reactor bank will be added for light load conditions voltage control. For high side protection and control, a 230-kV bay will be added. The 138-kV bay modifications consist of the upgrade of both transformer bays. The upgrades include the addition of bus work, breakers, and switches for protection and control. The project includes approximately 1400 feet of tie line conductor that extends outside of the fenced perimeter of the substation then loops back into the substation. The tie line will require the construction of three 230-kV H-frame steel structures in a corridor approximately 150 to 300 feet north of the substation fence. The tie line will run parallel to the north fence of the substation for approximately 900 feet before re-entering the substation. The area where the tie line is to be constructed is privately owned and tilled for agricultural purposes.

B4.6 Additions or Modifications to Electric Power Transmission Facilities

Additions or modifications to electric power transmission facilities within a previously disturbed or developed facility area. Covered activities include, but are not limited to, switchyard rock grounding upgrades, secondary containment projects, paving projects, seismic upgrading, tower modifications, load-shaping projects (such as the installation and use of flywheels and battery arrays), changing insulators, and replacement of poles, circuit breakers, conductors, transformers, and crossarms.

B4.12 Construction of Electric Powerlines

Construction of electric powerlines approximately 10 miles in length or less, or approximately 20 miles in length or less within previously disturbed or developed powerline or pipeline rights-of-way.

- Have the potential to cause significant impacts on environmentally sensitive resources. An environmentally sensitive resource is typically a resource that has been identified as needing protection through Executive Order, statute, or regulation by Federal, State, or local government, or a federally recognized Indian tribe. An action may be categorically excluded if, although sensitive resources are present, the action would not have the potential to cause significant impacts on those resources (such as construction of a building with its foundation well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). Environmentally sensitive resources include, but are not limited to, those listed in paragraph B. (4) (see Attachment A).

- 3) The proposal is not "connected" to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

D. Special Stipulations Pertaining to the Proposal:

If the scope of work of this project changes, Western's Environmental Division must be contacted for additional environmental review.

This Categorical Exclusion is valid for 2013/2014 after the signature date. If construction has not commenced within that time, Western's Environmental Division must be contacted for an updated environmental review prior to construction.

To comply with the Migratory Bird Treaty Act, if the work is to be done during the general nesting season which is March 1 through July 31, the maintenance crew will consult with Western's biologist to ensure that there are no nests in the project vicinity. Work conducted during the general nesting season will require a field biologist to survey areas in advance of the work crews. Western will provide the field biologist services.

If any cultural materials are discovered during construction, work in the area shall halt immediately, Western Regional Preservation Officer shall be contacted, and the material evaluated by an archaeologist or historian meeting the Secretary of the Interior's Professional Qualification Standards (48 FR 22716, Sept. 1983).

All equipment used must be cleaned prior to use in the area to prevent transporting of invasive plant or noxious weed seeds.
