Description:

A9 Information and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and gathering, analysis, audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. ## Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to Hawaii BioEnergy LLC to accelerate the development of a commercial industry for algae derived transportation fuels suitable for petroleum replacement. This NEPA determination applies to Task 1, "Project Management and Reporting" only. This task includes initial validation work, personnel management, and deliverables. Task 1 would allow DOE to verify the project's readiness to proceed and allow DOE to evaluate the recipient's technology readiness level and current state of technology.

Additional NEPA review is required prior to the authorization of federal funding for subsequent tasks.

Based on review of the project information, DOE has determined the proposed activities in Task 1 would not have a significant individual or cumulative impact to human health or the environment. DOE has determined that the proposed task is consistent with actions contained in DOE categorical exclusion A9, "information gathering, analysis and dissemination."

DOE has made a conditional NEPA determination for this award, and funding for certain tasks under this award is contingent upon the final NEPA determination.
