These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, manufacturers, and designers), organizations (such as utilities), and governments (such as state, local, and tribal). Covered actions could involve commercial, residential, agricultural, academic, institutional, or industrial sectors. Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to BlocPower to develop an online platform and marketplace that will provide for crowdsourced, risk tolerant microfinance of energy efficiency retrofits in underserved communities. This online platform and marketplace would be a website and social networking program that would function as a type of "crowdfunding" organization to do energy retrofits for communities that would otherwise not be able to afford to do them.

DOE and cost share funds would be used for three main tasks:

- 1. Create and program a website that brings together communities that need energy retrofits with investors who can support those retrofits.
- 2. Market the program above.

3. Perform energy audits to verify that the submitted energy retrofit concepts were viable, and there would be a reasonable level of assurance that investors would be see a return on their investment.

It is anticipated that all energy retrofits would be paid for completely by the investors who are then reimbursed with interest from the annual savings of those retrofits. If DOE or cost share funding were to be used for ground-breaking activities, new construction, or projects involving the installation of outside equipment, these activities would be subject to additional NEPA review by DOE prior to expenditure of project funds. Under Funding Opportunity Announcement (FOA) number DE-FOA-0000829, the recipient is prohibited from conducting retrofits on buildings of historic, archaeological, or architectural significance designated by federal, state or local governments, property located within or immediately adjacent to a historic district, property 50 years or older, or property eligible for listing on the National Register of Historic Places.

Based on review of the project information and the above analysis, DOE has determined the proposed project would not have a significant individual or cumulative impact to human health and/or environment. DOE has determined the proposed project is consistent with actions contained in DOE categorical exclusion A9 "information gathering," A11 "technical advice and assistance," and B5.1 "actions to conserve energy," and is categorically excluded from further NEPA review.
