Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B3.6 Small-scale research and development, and pilot projects

Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) laboratory operations, frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to ABB, Inc. to develop a novel and compact direct-drive electric generator and its system aspects that would enable elimination of hydraulic components in the Power Take-Off (PTO) of a Marine and Hydrokinetic (MHK) system with an oscillating wave surge converter (OWSC). DOE funding would be used for two phases to design, manufacture and test two alternative one kilowatt, 300 revolution-per-minute proof-of-concept machines, a larger 10 kilowatt, 30 revolution-per-minute prototype and eventually, a full-scale, direct-drive electrical generator for integration with a wave energy converter.

Phase One proof-of-concept development would occur at ABB, Inc. located at 940 Main Campus Drive, Raleigh, North Carolina. Phase Two prototype development would occur at Texas A&M University located at 3128 TAMU, College Station, Texas. Analysis activities would occur at Resolute Marine Energy located at 3 Post Office Square, Boston, Massachusetts. ABB, Inc. completed an environmental questionnaire addressing the protocols for laboratory safety, risk management, chemical handling and waste disposal for all locations. The research facilities comply with standard safety procedures and all processes and procedures are monitored by appropriate staff. The research facilities have all applicable permits in place, and would not need additional permits for the proposed activities. All handling and disposal of gases, chemicals, wastes and liquid effluents comply with appropriate regulations.

Based on review of the project information and the above analysis, DOE has determined the proposed research and development activities would not have a significant individual or cumulative impact to human health and/or environment. DOE has determined the proposed project is consistent with actions contained in DOE categorical exclusion A9 "information gathering, analysis and dissemination," and B3.6 "small-scale research and development projects" and is categorically excluded from further NEPA review.
