Proposed Action Description:

LanzaTech Inc., in conjunction with the Louisiana State University, City University of New York, Michigan Technological University, and University of California San Diego, proposes to conduct small-scale, laboratory based, research and development of bioreactor systems for methane fermentation to biofuels. The proposed project aims to optimize design to lower cost and energy inputs compared to conventional bioreactors.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
