Proposed Action Title: Henderson 230kV Switchyard (Erosion Control)

Program or Field Office: Western Area Power Administration, Desert Southwest Regional Office

Location(s) (City/County/State): Henderson, Clark County, Nevada

Proposed Action Description:

Western plans to conduct erosion repair within the existing Henderson Switchyard located in Henderson, Clark County, Nevada. The project is on federal land (Western-owned) property in Section 13, Township 22S, Range 62E of the Mt. Diablo Meridian. The purpose of the project is to repair erosion which has occurred along several areas of the fence perimeter; provide safety and security to personnel due to washouts; and eliminate potential of unauthorized entry. The project is needed to maintain reliability, safety, and environmental requirements.

The proposed project consists of backfilling and compacting approximately ten tons of approved fill material on damaged areas along the north, northeast, and east of fence property.

Equipment used on site may include a backhoe, bobcat, tractor, bucket, and crew truck for all stages of the construction work. Western will use the existing access road to carry equipment and personnel to site. Project activities are anticipated to start no sooner than March, 2014 and completed no later than September, 2014.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.


