**Wray-Wray Tap 115-kV Transmission Line Construction, Yuma County, Colorado**

**A. Brief Description of Proposal:** Western Area Power Administration (Western) Eastern Colorado Maintenance Office proposes to rebuild 2.1 miles of its 115-kV transmission line between the Wray Substation and the Wray Tri-State Generation and Transmission Association, Inc., substation in eastern Colorado. The rebuild project is part of Western's ongoing planned maintenance and would replace in-kind 18 aging (constructed circa 1949) H-frame wood pole structures and two dead-end structures. The structures are presently 55-65 feet tall. Some of the structures may be replaced with structures that are 5-10 feet taller than the existing structures in order to comply with regulations concerning conductor ground clearances. Invenergy Wind Development, LLC (Invenergy), has proposed that the conductors in this segment be upgraded from the existing 266.8 kcmil aluminum conductor steel reinforced (ACSR) to 477 kcmil ACSR. The conductor upgrade portion of the project would be funded by Invenergy to improve its transmission from the Wray Wind Energy Project located north of Wray, Colorado. If the conductor upgrade project is not accomplished this year, the structures and conductor will be replaced in-kind with some taller structures. In either scenario, the project will require access to each structure using tracked and rubber-tired vehicles. Access road maintenance will be conducted as required in order to access each structure. The project is scheduled to be constructed in October 2014.

**B. Number and Title of the Categorical Exclusion Being Applied:** (See text in 10 CFR Part 1021, Subpart D.)

B4.12 Construction of electric powerlines approximately 10 miles in length or less, or approximately 20 miles in length or less within previously disturbed or developed powerline or pipeline rights-of-way.

**C. Regulatory Requirements in 10 CFR 1021.410 (b):** (See full text in regulation and attached checklist.)

1) The proposed action fits within a class of actions listed in Appendix A or B to Subpart D.

For classes of actions listed in Appendix B, the following conditions are integral elements. To fit within a class, the proposal must not:

- Threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety and health, or similar requirements of DOE or Executive Orders;
- Require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities;
- Disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases;
- Have the potential to cause significant impacts on environmentally sensitive resources. An environmentally sensitive resource is typically a resource that has been identified as needing protection through Executive Order, statute, or regulation by Federal, State, or local government, or a federally-recognized Indian tribe. An action may be categorically excluded if, although sensitive resources are present, the action would not have the potential to cause significant impacts on those resources (such as construction of a building with its foundation

well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). Environmentally sensitive resources include, but are not limited to, those listed in paragraph B. (4) (see Attachment A).

- 2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
- 3) The proposal is not “connected” to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

**D. Special Stipulations Pertaining to the Proposal:**

If the scope of work of this project changes, Western’s Environmental Division must be contacted for additional environmental review.

This Categorical Exclusion is valid for the 2014 field season after the signature date. If construction has not commenced within that time, Western’s Environmental Division must be contacted for an updated environmental review prior to construction.

If any used treated wood poles or cross-arms are donated, Western will obtain a signed “acknowledgment of receipt” of Western’s Consumer Information Sheet for Treated Wood Poles and Cross-Arms from the person receiving the used poles and/or cross-arms.

If any cultural materials are discovered during construction, work in the area shall halt immediately, Western’s Regional Preservation Officer shall be contacted, and the material evaluated by an archaeologist or historian meeting the Secretary of the Interior’s Professional Qualification Standards (48 FR 22716, Sept. 1983).

All equipment used must be cleaned prior to use to prevent transporting of invasive plant or noxious weed seeds.

To comply with the Migratory Bird Treaty Act, maintenance work should be scheduled outside the March 1 through July 31 general nesting periods. If the maintenance work is to be done during this period, contact Western’s Environmental Division so that they may arrange for a pedestrian survey to be conducted in advance of the maintenance crews to identify active nests that are to be avoided.


Western shall exercise care to preserve the natural landscape and shall conduct this construction operation to prevent any unnecessary destruction, scarring, or defacing of the natural surroundings in the project vicinity. Except where clearing is required for permanent works, approved construction roads, or excavation operations, and vegetation shall be preserved and shall be protected from damage by Western’s construction operations and equipment.
