Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Order 451.1A), I have made the following determination:

Description:

A9 Information and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and gathering, analysis, audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to the Hydro Research Foundation (HRF) to award grants to individual research projects through its University Research Awards Program. The intent of the grants is to support innovative research related to conventional or pumped-storage hydropower, stimulate interest among students and universities in this research arena, and provide students with a foundation for productive careers related to the hydropower industry.

DOE completed a previous NEPA review (GFO-0006506-001 CX A9 2/7/2014) that included development of a Hydro Fellowship Program that would competitively award hydro-power related, graduate-level research projects for one-totwo year periods of study. This NEPA determination applies to activities associated with one of the projects which has been selected to receive a grant award from the HRF.

The awardee at Pennsylvania State University would use HRF grant funding to use computer simulations to investigate methods to increase turbine efficiencies under various operating conditions and will develop simulations for optimizing the operation of hydraulic turbines. The proposed project would consist of computer modeling and data analysis.

Based on a review of the project information and the above analysis, DOE has determined that activities associated with the Pennsylvania State University proposed project would not have significant individual or cumulative impact to human health and/or environment. DOE has determined that the work outlined is consistent with the actions identified in categorical exclusion A9 "information gathering," and is categorically excluded from further NEPA review.
