Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Order 451.1A), I have made the following determination:

Description:

A9 Information

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and gathering, analysis, audits), data analysis (including, but not limited to, computer modeling), document preparation and dissemination (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B5.16 Solar photovoltaic systems

The installation, modification, operation, and removal of commercially available solar photovoltaic systems located on a building or other structure (such as rooftop, parking lot or facility, and mounted to signage, lighting, gates, or fences), or if located on land, generally comprising less than 10 acres within a previously disturbed or developed area. Covered actions would be in accordance with applicable requirements (such as local land use and zoning requirements) in the proposed project area and would incorporate appropriate control technologies and best management practices.

## Rationale for determination:

The Forest County Potawatomi Community (FCPC or the Tribe) would utilize DOE and cost share funding to install and operate approximately 875 kW of solar photovoltaic systems at 10 tribal facilities in Milwaukee and Forest Counties in the State of Wisconsin. The individual installations are expected to range in size from 11kW to 545kW. Project activities include design work, bid and agreement preparation, reporting, etc.

All installations would occur at Tribally-owned buildings and sites with seven of the ten systems being roof mounted. The locations shown in the facilities list uploaded into the PMC (Updated Facilities and Sizing List and Calculations (00354196xB15CF).pdf) as Emergency Management/Family Resource, Natural Resources Building/Garage, and Air Monitoring Site are expected to have ground mounted systems installed on approximately one third of acre total for all three systems within previously disturbed areas adjacent to each building. Nine of the ten installations would occur on lands held in trust by the United States for FCPC. Because this project is being completed by the Tribe for the Tribe's benefit, it is not expected than any federal approvals from the Bureau of Indian Affairs will be required. None of the proposed locations are eligible or listed as historic, are within a historic district, or are viewable from within a historic district. There are no resources of concern associated with the proposed project activities.

Based on review of the project information, DOE has determined that the project activities would not have a significant individual or cumulative impact to human health and/or environment. DOE has determined that these activities are consistent with actions contained in DOE categorical exclusions A9 "Information gathering, analysis, and dissemination," and B5.16 "Solar photovoltaic systems," and is categorically excluded from further NEPA review.
