B5.1 Actions to (a) Actions to conserve energy or water, demonstrate potential energy or water conservation, and promote energy efficiency that would not have the potential to cause significant changes in the indoor or outdoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, manufacturers, and designers), organizations (such as utilities), and governments (such as state, local, and tribal). Covered actions include building renovations or new structures, provided that they occur in a previously disturbed or developed area. Covered actions could involve commercial, residential, agricultural, academic, institutional, or industrial sectors. Covered actions do not include rulemakings, standard-settings, or proposed DOE legislation, except for those actions listed in B5.1(b) of this appendix. Rationale for determination:

The Department of Energy is proposing to provide funding to the Pacific International Center for High Technology Research (PICHTR), to fund Shifted Energy to expand the commercialization of their product which helps to align the availability of renewable energy with end use demand through a system that manages an interconnected network of devices that shift energy loads up or down on demand. The excess energy is stored in water tanks for use later by ratepayers effectively creating a thermal battery. The proposed action would replace ten older model water heaters in homes with higher energy efficiency water heaters that have thermistors to measure the heater, a router, and a load controller. All the equipment is UL listed. Additionally, Shifted Energy would participate in PICHTR's Energy Excelerator outreach activities. The Energy Excelerator Program assists small renewable energy projects with business development needs. Shifted Energy is a sub-recipient to PICHTR's award DE-FG-36-08GO88146.

The ten homes would be located throughout Oahu and Maui, and some of the homes may be over 50 years old. No alterations would be made to the exterior of any of the homes.

This project would include data analysis, computer modeling, information dissemination, training, conferences and

informational programs, as well as laboratory scale research and development.
