RECORD OF CATEGORICAL EXCLUSION DETERMINATION

Project ID No. WH-OM-1194

Title: Replace WH Ported Coax at NW Perimeter

Description: Subcontractor shall furnish all labor, materials, tools, equipment, supplies, transportation,

supervision and services required to replace the ported coaxial cable sensor (PCCS) at the northwest perimeter fence at the WH SPR site. Tasks include de-energization of all powered components, excavation and removal of existing PCCS components, site preparation (filling or grading of terrain), and installation of new buried PCCS cables. The excavation work is not located in wetlands, but the offsite property beyond the fence is wetland area. All work must be performed within the non-wetland area adjacent to both

sides of the WH perimeter fence.

Regulatory Requirements: NEPA Implementing Procedures (10 CFR 1021)

10 CFR 1021.410 (Application of Categorical Exclusions)

- (a) The actions listed in Appendices A and B of Subpart D are classes of actions that DOE has determined do not individually or cumulatively have a significant effect on the human environment (categorical exclusions).
- (b) To find that a proposal is categorically excluded, DOE shall determine the following:
 - (1) The proposed action fits within a class of actions that is listed in Appendix A or B of Subpart D;
 - (2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal; and
 - (3) The proposal is not "connected" (40 CFR 1508.25(a)(1)) to other actions with potentially significant impact, is not related to other proposed actions with cumulatively significant impacts (40 CFR 1508.25(a)(2)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

Appendix B (Categorical Exclusions Applicable to Specific Agency Actions)

The proposed action must not:

- 1. Threaten a violation of statutory, regulatory, or permit requirements for environment, safety, and health, including requirements of DOE and/or Executive Orders.
- 2. Require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities, but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions.
- Disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and /natural gas products that preexist in the environment such that would be uncontrolled or unpermitted releases; or
- 4. Adversely affect environmentally sensitive resources.

Categorical Exclusion to be applied: <u>B1.7</u>

Acquisition, installation, operation, modification, and removal of electricity transmission control and monitoring devices for grid demand and response, communication systems, data processing equipment, and similar electronic equipment.
