Proposed Action: Sale of Pennwalt Tap to PGE Harborton-Station E Line

Categorical Exclusion Applied (from Subpart D, 10 C.F.R. Part 1021): B1.24 Property

Location: Multnomah County, Oregon

Proposed by: Bonneville Power Administration (BPA)

<u>Description of the Proposed Action</u>: BPA proposes to transfer title to its Pennwalt Tap to Portland General Electric's (PGE) Harborton-Station E 115-kV Transmission Line (Pennwalt Tap) to PGE.

BPA acquired the Pennwalt Tap from PGE in 1982 and PGE maintained ownership of an electrical distribution line underbuild to serve the local industrial customers. In 2002, BPA stopped using the line but the BPA conductors were left on the poles unenergized. PGE owns three of the nine tap line poles and BPA owns the other six poles with attached conductors. Since BPA has no further interest in the line tap, PGE has requested ownership of the remaining portion of the line tap.

BPA would transfer ownership of all assets that make up the tap line, including the structures, footings, conductor, and support equipment. This project would not include the sale of land rights, as the structures and equipment are located on public right-of-way.

The transfer of ownership would not change the use of the equipment and would not have the potential to release substances at a level, or in a form, that could pose a threat to public health or the environment.

Findings: BPA has determined that the proposed action complies with Section 1021.410 and Appendix B of Subpart D of the Department of Energy's (DOE) National Environmental Policy Act (NEPA) Regulations (57 FR 15144, Apr. 24, 1992, as amended at 61 FR 36221-36243, July 9, 1996; 61 FR 64608, Dec. 6, 1996, 76 FR 63764, Nov. 14, 2011). The proposed action does not present any extraordinary circumstances that may affect the significance of the environmental effects of the proposal. The proposal is not connected [40 C.F.R. 1508.25(a)(1)] to other actions with potentially significant impacts, has not been segmented to meet the definition of a categorical exclusion, is not related to other proposed actions with cumulatively

significant impacts [40 C.F.R. 1508.25(a)(2)], and is not precluded by 40 C.F.R. 1506.1 or 10 C.F.R. 1021.211. Moreover, the proposed action would <u>not</u> (i) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, (ii) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities, (iii) disturb hazardous substances, pollutants, contaminants, or Comprehensive Environmental Response, Compensation and Liability Act-excluded petroleum and natural gas products that pre-exist in the environment such that there would be uncontrolled or unpermitted releases, (iv) have the potential to cause significant impacts on environmentally sensitive resources, or (v) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements.

This proposed action meets the requirements for the Categorical Exclusion referenced above. We therefore determine that the proposed action may be categorically excluded from further NEPA review and documentation.
