<u>Description of the Proposed Action</u>: BPA proposes to acquire several road easements to provide dedicated access to its Holcomb-Naselle No. 1 Transmission Line in Pacific County, Washington. The acquisitions would ensure permanent legal access to the line for operation and maintenance purposes. These acquisitions would perfect access rights and reflect current use of existing facilities.

New access road easements would generally be 20 feet wide. There are no planned improvements associated with these acquisitions.
