Categorical Exclusion Applied (from Subpart D, 10 C.F.R. Part 1021): B4.6 Additions and modifications

<u>Description of the Proposed Action</u>: BPA proposes to raise the height of an H-frame wood pole structure to remove a critical line impairment on the BPA Ellensburg-Moxee 115-kV transmission line between structures 5/6 and 5/7. An impairment is an area where the distance from the conductor to the ground surface is inadequate, per National Electrical Safety Code (NESC) standards, resulting in a threat to line reliability and posing a risk to public health and safety. The proposed work is necessary to ensure the line meets current National Electrical Safety Code (NESC) and Federal Energy Regulatory Commission (FERC) standards.

The proposed action is to raise the height of structure 5/7 approximately 18-feet by replacing wood poles in the same location. Cross-bar supports would also be added to the rebuilt structure. All work will occur in the existing, cleared right-of-way corridor on flat to moderate slopes using existing access roads. The action is on privately-owned land. Equipment is likely to include a combination of the following: a dump truck, a bulldozer, a backhoe, an excavator, and work trucks. The sites and any redistributed material will be contoured to match surrounding terrain, seeded, and mulched to prevent erosion and provide site stabilization.

The proposed work is necessary to ensure ongoing safe and reliable operation of the transmission line to minimize risk of outages and maintain power delivery in the region. Due to the urgent nature of the activity, BPA is proposing to perform the work in summer 2015. All work will be in accordance with NESC and BPA standards.

<u>Findings</u>: In accordance with Section 1021.410(b) of the Department of Energy's (DOE) National Environmental Policy Act (NEPA) Regulations (57 FR 15144, Apr. 24, 1992, as amended at 61 FR 36221-36243, July 9, 1996; 61 FR 64608, Dec. 6, 1996, 76 FR 63764, Nov. 14, 2011), BPA has determined that the proposed action:

- (1) fits within a class of actions listed in Appendix B of 10 CFR 1021, Subpart D (see attached Environmental Checklist);
- (2) does not present any extraordinary circumstances that may affect the significance of the environmental effects of the proposal; and
- (3) has not been segmented to meet the definition of a categorical exclusion.

Based on these determinations, BPA finds that the proposed action is categorically excluded from further NEPA review.
