- A. Brief Description of Proposal:** Western Area Power Administration (Western), proposes to conduct routine maintenance and replace and heighten a wood pole H-frame Structure 39/10 along the Casper PACE-Spence 230-kV Transmission Line. PacifiCorp has requested to cross under Western's transmission line at this location with a new transmission line that PacifiCorp is constructing. In order to maintain proper electrical conductor clearances, this requires Western to raise Structure 39/10 by 10 feet. Western will also provide right-of-way (ROW) use through an agreement with PacifiCorp. The project is located on privately owned land in Natrona County, Wyoming. Western would replace the current 75-HSB-1 structure with an 85-HSB-1 structure at location 39/10. The equipment utilized may be a crane, manlift, backhoe, rubber-tired pressure digger/derrick, skid-steer loader, pole trailer, and line trucks.
- B. Number and Title of the Categorical Exclusion Being Applied:** (See text in 10 CFR Part 1021, Subpart D.)

B4.6. Additions or Modifications to Electric Power Transmission Facilities.

Additions or modifications to electric power transmission facilities within a previously disturbed or developed facility area. Covered activities include, but are not limited to, switchyard rock grounding upgrades, secondary containment projects, paving projects, seismic upgrading, tower modifications, load-shaping projects (such as the installation and use of flywheels and battery arrays), changing insulators, and replacement of poles, circuit breakers, conductors, transformers, and crossarms.

- C. Regulatory Requirements in 10 CFR 1021.410 (b):** (See full text in regulation and attached checklist.)

- 1) The proposed action fits within a class of actions listed in Appendix A or B to Subpart D.

For classes of actions listed in Appendix B, the following conditions are integral elements. To fit within a class, the proposal must not:

- Threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders;
- Require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities;
- Disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases;
- Have the potential to cause significant impacts on environmentally sensitive resources. An environmentally sensitive resource is typically a resource that has been identified as needing protection through Executive Order, statute, or regulation by Federal, State, or local government, or a federally recognized Indian tribe. An action may be categorically excluded if, although sensitive resources are present, the action would not have the

building with its foundation well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). Environmentally sensitive resources include, but are not limited to, those listed in paragraph B. (4) (see Attachment A).

- 2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
- 3) The proposal is not "connected" to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

D. Special Stipulations Pertaining to the Proposal:

If the scope of work of this project changes, Western's Environmental Division must be contacted for additional environmental review.

This Categorical Exclusion is valid only from signature date through the end of calendar year 2015. If construction has not commenced within that time, Western's Environmental Division must be contacted for an updated environmental review prior to construction.

If any cultural materials are discovered during construction, work in the area shall halt immediately, Western's Regional Preservation Officer shall be contacted, and the material be evaluated by an archaeologist or historian meeting the Secretary of the Interior's Professional Qualification Standards (48 FR 22716, Sept. 1983).

Limit movement of construction crews and equipment within the maintenance corridor, including access routes, to minimize damage within the ROW corridor. Maintenance activities shall be conducted to minimize scarring, or defacing of the natural surroundings in the vicinity of the work. Except where terrain damage results, terrain and vegetation shall be preserved and protected from damage by maintenance crew operations and equipment.

To minimize impacts to the environment and prevent damage to access roads, operation of off-road equipment will not be permitted during periods of heavy rains, when soils are wet, or when excessive soil damage may occur due to unsuitable operating conditions. No construction or routine maintenance activities shall be performed during periods when the soil is too wet to adequately support construction equipment. If equipment creates ruts in excess of six inches deep, the soil shall be deemed too wet to adequately support construction equipment.

To comply with the Migratory Bird Treaty Act, maintenance work should be scheduled outside the March 1 through July 31 general nesting periods. If the maintenance work is to be done during this period contact Western's Environmental Division so that they may arrange for a pedestrian survey to be conducted in advance of the maintenance crews to identify active nests that are to be avoided.



Western would implement standard best management practices for erosion, seeding, and noxious weed control. Western's clean vehicle policy will apply, and all equipment used will be washed and cleaned prior to use in the area to prevent transporting of invasive plant or noxious weed seeds.

If the used poles are sold or donated, the Project Manager will ensure the recipients have read and signed Western's consumer information sheet for treated wood poles and crossarms.

There will be no blading or grading of access.

- E. Determination:** Based on my review of information provided to me and in my possession concerning the proposed action, I determined that the proposed action fits within the specified class of actions, the other regulatory requirements set forth above are met, and the proposed action is categorically excluded from requirements for an EA or an EIS.
