### Happy Jack 230-kV Substation Fiber Optic Installation Laramie County, Wyoming

- A. **Brief Description of Proposal:** Western Area Power Administration (Western) proposes to bury new conduit for a fiber optic cable at the Happy Jack Substation in Laramie County, Wyoming. The installation requires approximately 50-feet of trenching within Western's Happy Jack Substation fenced perimeter and approximately 450-feet duc east along the Cheyenne to Snowy Range 230-kV Transmission Line right-of-way (ROW) to Structure 5-5. The conduit will be mounted and raised up the transmission pole then the fiber optic line will be fed into the new conduit to the fiber optic cable access point. The Happy Jack Substation is located in Section 5, Township 13 North, Range 67 West, of the 6th Principal Meridian. The substation is a graveled yard surrounded by a chain-link perimeter fence. The trench will be approximately 6-8 inches wide, 2-feet deep, and approximately 500-feet in total length.

A pickup truck and Ditch Witch RT-45 trencher will be used to dig and fill the trench, and minor back filling will be done with the trencher blade. All trench work will be conducted within a construction corridor footprint approximately 40-feet wide.

- B. **Number and Title of the Categorical Exclusion Being Applied:** (See text in 10 CFR Part 1021, Subpart D.)

#### **B4.7 Fiber Optic Cable:**

**Adding fiber optic cables to transmission facilities or burying fiber optic cable in existing powerline or pipeline rights-of-way.** Covered actions may include associated vaults and pulling and tensioning sites outside of rights-of-way in nearby previously disturbed or developed areas.

- 1) The proposed action fits within a class of actions listed in Appendix A or B to Subpart D.

For classes of actions listed in Appendix B, the following conditions are integral elements. To fit within a class, the proposal must not:

- Threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders;
- Require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities;
- Disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases;
- Have the potential to cause significant impacts on environmentally sensitive resources. An environmentally sensitive resource is typically a resource that has been identified as needing protection through Executive Order, statute, or regulation by Federal, State, or local government, or a federally recognized Indian tribe. An action may be categorically excluded if, although sensitive resources are present, the action would not have the potential to cause significant impacts on those resources (such as construction of a building

with its foundation well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). Environmentally sensitive resources include, but are not limited to; those listed in paragraph B. (4) (see Attachment A).

- 2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
- 3) The proposal is not "connected" to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

**D. Special Stipulations Pertaining to the Proposal:**

If the scope of work of this project changes, Western's Environmental Division must be contacted for additional environmental review.

This Categorical Exclusion is valid only from signature date through the end of calendar year 2015. If construction has not commenced within that time, Western's Environmental Division must be contacted for an updated environmental review prior to construction.

All work will be conducted using an existing access road. Minor access road maintenance may be required and use special care to avoid areas immediately southeast and northwest of the substation identified as freshwater emergent wetland and known environmentally sensitive resources. Maintenance crews will ensure that a 40-foot maximum construction corridor footprint is necessary to conduct the trenching operation.

Western shall exercise care to preserve the natural landscape and shall conduct this construction operation to prevent any unnecessary destruction, scarring, or defacing of the natural surroundings in the project vicinity. Except where clearing is required for permanent works, approved construction roads, or excavation operations, vegetation shall be preserved and shall be protected from damage by Western's construction operations and equipment.

All vehicles will use existing access roads and ROW. The project is anticipated to cause minimum disturbance of existing grasslands as there is the potential for environmentally sensitive resources in the project area. Sensitive areas have been identified on maps that will be provided to construction crews prior to commencing any ground disturbing activity.

If any cultural materials are discovered during construction, work in the area shall halt immediately, Western's Preservation Officer shall be contacted, and the material be evaluated by an archaeologist or historian meeting the Secretary of the Interior's Professional Qualification Standards (48 FR 22716, Sept. 1983).
