Proposed Action: Mulkey Ridge Property Acquisition Funding and Stewardship Funding

Location: Corvallis Quadrangle, in Benton County, Oregon (near Corvallis, Oregon).

<u>Categorical Exclusion Applied (from Subpart D, 10 C.F.R. Part 1021)</u>: B1.25 Real property transfers for cultural resources protection, habitat preservation, and wildlife management

<u>Description of the Proposed Action</u>: BPA is proposing to fund Greenbelt Land Trust to purchase the Mulkey Ridge, a 170-acre parcel of land located 1 mile west of Corvallis, in Benton County, Oregon. The property would be placed under a conservation easement to provide long-lasting wildlife benefits by preventing the conversion of fish and wildlife habitat to other land uses. BPA would also provide stewardship funds toward maintenance of the property to the landowner, Greenbelt Land Trust.

Funding the purchase of the property and long-term stewardship would partially fulfill commitments made in the 2010 "Willamette River Basin Memorandum of Agreement Regarding Wildlife Habitat Protection and Enhancement between the State of Oregon and the Bonneville Power Administration." This is part of BPA's ongoing efforts to mitigate for impacts to fish and wildlife of the construction and operation of federal flood control facilities in the Willamette River Basin. Placing this property in a conservation easement would provide long-lasting wildlife benefits as part of a growing network of conservation lands in the Willamette Valley that are preventing the conversion of fish and wildlife habitat to other land uses.

The property consists of 170 acres of oak savanna, oak woodland, and riparian forest and shrubland bordering the Mulkey Creek. The Greenbelt Land Trust would provide long-term stewardship of the land and develop a management plan to guide the protection and enhancement of habitat and other resources on the property. The management plan would be reviewed by BPA for consistency with the agreement and purpose of the acquisition. If BPA proposes to fund any management activities on the property, additional environmental review would be conducted.

<u>Findings</u>: In accordance with Section 1021.410(b) of the Department of Energy's (DOE) National Environmental Policy Act (NEPA) Regulations (57 FR 15144, Apr. 24, 1992, as amended at 61 FR 36221-36243, July 9, 1996; 61 FR 64608, Dec. 6, 1996, 76 FR 63764, Nov. 14, 2011), BPA has determined that the proposed action:

- (1) fits within a class of actions listed in Appendix A of 10 CFR 1021, Subpart D (see attached Environmental Checklist;
- (2) does not present any extraordinary circumstances that may affect the significance of the environmental effects of the proposal; and
- (3) has not been segmented to meet the definition of a categorical exclusion.

Based on these determinations, BPA finds that the proposed action is categorically excluded from further NEPA review.


