Categorical Exclusion Applied (from Subpart D, 10 C.F.R. Part 1021): B4.7 Fiber Optic Cable

<u>Description of the Proposed Action</u>: BPA proposes to install approximately 0.5 mile of underground fiber optic cable between BPA's Chief Joseph Substation and Douglas County Public Utility District's Foster Creek Substation. The proposed fiber is needed to support upgrades to the existing analog communication path with the generating plant at Wells Dam. The fiber optic cable would be installed in an area approximately 120 to 150 feet northeast of Chief Joseph Substation Road using horizontal directional drilling. In addition to the fiber optic cable, BPA would install one below ground fiber optic cable vault immediately outside the perimeter fence at each substation. From each of these vaults BPA would extend the fiber optic cable to the Chief Joseph and Foster Creek control houses using existing underground conduit. BPA would also install related electrical components within each control house.

<u>Findings</u>: In accordance with Section 1021.410(b) of the Department of Energy's (DOE) National Environmental Policy Act (NEPA) Regulations (57 FR 15144, Apr. 24, 1992, as amended at 61 FR 36221-36243, July 9, 1996; 61 FR 64608, Dec. 6, 1996, 76 FR 63764, Nov. 14, 2011), BPA has determined that the proposed action:

- (1) fits within a class of actions listed in Appendix B of 10 CFR 1021, Subpart D (see attached Environmental Checklist);
- (2) does not present any extraordinary circumstances that may affect the significance of the environmental effects of the proposal; and
- (3) has not been segmented to meet the definition of a categorical exclusion.

Based on these determinations, BPA finds that the proposed action is categorically excluded from further NEPA review.

Proposed Action: Chief Joseph-Foster Creek Underground Fiber Optic Cable Installation

Project Site Description

The project site is located on BPA fee-owned land adjacent to the Chief Joseph Substation near the town of Bridgeport, Washington. Existing vegetation consists of rabbitbrush, sagebrush, and invasive weeds such as tumblemustard. An unnamed ephemeral tributary to Foster Creek flows through two culverts located under Chief Joseph Substation Road. The surrounding landscape consists of open space, fruit orchards, and one residence approximately 500 feet north of Foster Creek Substation.
