Proposed Action Title: Dome-Wellton-Mohawk-Ligurta 161-kV Transmission Line Maintenance

Program or Field Office: Western Area Power Administration, Desert Southwest Region

Location(s) (City/County/State): Wellton, Yuma County, Arizona

Proposed Action Description:

Western Area Power Administration (Western) proposes to conduct maintenance activities on the existing Dome-Wellton-Mohawk-Ligurta 161-kV transmission line located in Yuma County, Arizona (Figure 1). Based on detailed ground and aerial patrols, Western identified numerous deficiencies along the line due to normal wear and aging of the infrastructure. The project is needed to ensure the safe and reliable operation of the bulk electrical system. The Dome-Wellton-Mohawk-Ligurta 161-kV transmission line provides a power to the Wellton-Mohawk Irrigation District; therefore, it serves a critical function regarding electrical power supply in the region.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

# Dome-Wellton-Mohawk-Ligurta 161-kV Transmission Line Wellton, Yuma County, Arizona Categorical Exclusion Continuation Sheet

#### **Project Description**

Western proposes to conduct routine maintenance on the existing transmission line between the Dome Tap and the Wellton-Mohawk-Ligurta substation, including the following:

- · Repair or replace cross braces and cross arms
- Replace damaged or missing insulators
- · Repair or patch static wires
- · Replace signs and aerial markers
- · Repair or secure ground wires
- Tighten, replace, or install braces, bolts, static bands, and other minor appurtenant hardware

Access to the transmission line structures will be via existing public and private roads. No road repairs or other earthwork will be conducted as part of the proposed maintenance activities. Equipment used to conduct maintenance may include bucket trucks and crew trucks (F-550 or similar).

Maintenance activities will begin no sooner than September 14, 2015, and will be completed by October 30, 2015.
