Proposed Action Title: Magneto-Inertial Fusion Technologies, Inc. (MIFTI) - Staged Z-Pinch for Fusion

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Tustin, CA; Reno, NV; San Diego, CA; and Albuquerque, NM

Proposed Action Description:

Funding will support research and development of a Staged Z-Pinch (SZP) to efficiently transfer energy to a plasma target. The SZP will use shock heating to rapidly deliver energy to the plasma target, which could mitigate instabilities that inhibit efficient plasma heating and confinement. If successful, this project will demonstrate a target that can scale to fusion-relevant conditions and could accelerate potential low-cost development paths to fusion power.

All research and development activities will be conducted in existing applied physics laboratory facilities, which are designed for such activities, at the University of Nevada (UNR) in Reno, NV and the University of California, San Diego (UCSD) in San Diego, CA. MIFTI's and Voss Scientific LLC's participation in the proposed project will be limited theoretical and computer simulation work performed in their Tustin, CA and Albuquerque, NM office facilities. All project activities will be performed in accordance with applicable Federal, State, and local safety and environmental requirements. Laboratory personnel performing tasks at UNR and UCSD which involve high-voltage, pulsed power, or equipment capable of generating neutrons will be trained and certified by university compliance personnel in safely operating such equipment.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
