Categorical Exclusion Determination Form

<u>Proposed Action Title</u>: University of California, San Diego - Advanced Energy Storage Modeling, Performance Evaluation, and Testing at the University of California, San Diego

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): La Jolla, CA

Proposed Action Description:

The University of California, San Diego (UCSD) will conduct laboratory-based research and development activities to identify promising advanced energy storage systems. Specifically, UCSD will (1) assess the economic benefits of a battery system connected to a microgrid; (2) simulate the operation of the battery system; (3) test battery systems at varying stages of readiness under controlled conditions; and (4) interconnect up to five 1-10kW storage devices for up to 24 months to assess device performance under actual microgrid operating conditions.

All laboratory-based research activities will take place at UCSD's facilities in La Jolia, CA. Outdoor testing will take place on concrete pads in a pre-disturbed area, will incorporate appropriate control technologies and best management practices, and will comply with applicable local, state and federal regulations and procedures.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; (2) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; (3) disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; (4) have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of 10 CFR Part 1021, Subpart D, Appendix B; (5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508,25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508,27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021,211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
