Proposed Action Title: MAHLE Powertrain, LLC (MAHLE) - Advanced Lean Burn Micro-CHP GENSET

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Farmington Hills, MI; Knoxville, TN; Baltimore, MD; Las Vegas, NV; and Kohler, WI

## Proposed Action Description:

Funding will support research and development activities to develop and optimize a residential Combined Heat and Power (CHP) system that integrates an Internal Combustion Engine (ICE) with a Turbulent Jet Ignition (TJI) combustion system. Use of a TJI combustion system that also incorporates an auxiliary-fueled pre-chamber combustor - in conjunction with a novel, low-temperature after-treatment system to reduce exhaust emissions - could enable the CHP system to operate under ultra-lean conditions and increase thermal efficiency. If successful, widespread deployment of highly efficient, compact, economical, and long-life residential CHP systems in the United States could lead to significant energy savings and a reduction in CO2 emissions associated with power plant electricity generation and household heating.

All research and development activities will be conducted in MAHLE's industrial facility in Farmington Hills, MI; Oak Ridge National Laboratory's laboratory facility in Knoxville, TN; Louthan Engineering's light industrial facility in Baltimore, MD; and Intellichoice Energy's industrial facility in Las Vegas, NV. Kohler Engine's role in the proposed project will be limited to theoretical and computer simulation work performed in its Kohler, WI office facility. All work will be performed in accordance with applicable Federal, State, and local safety and environmental requirements.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
