<u>Proposed Action Title</u>: LI-COR Biosciences, Inc. - Novel Laser Spectroscope Methane Sensor with Revolutionary High Performance/Low Cost to Enable Ultra-Sensitive Methane Leak Detection Systems of the Oil and Gas Industry

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Lincoln, NE; Santa Clara, CA; Fort Collins, CO; Sunnyvale, CA

Proposed Action Description:

Funding will support efforts to develop a laser spectroscopic methane sensor tailored to enable many new types of methane emission detection systems for all phases of oil and gas development. The sensor will rely on an optical cavity that provides long path length and high sensitivity.

LI-COR will conduct optical experiments, design and prototype optical instruments, and conduct data analysis and simulations, all in existing facilities. Subrecipient Gener8 will perform small scale assembly of optical components and conduct simulations in existing facilities. Subrecipient Colorado State University will test the instrument prototypes in existing laboratory facilities and the field. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local requirements. While levels of methane released during any laboratory or field testing will be de minimis, applicable safety protocols will be followed.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
