Proposed Action Title: Panasonic Boston Laboratory - Low Profile CPV Panel with Sun Tracking for Rooftop Installation

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Newton, MA

Proposed Action Description:

Funding will support the project team's small-scale, research and development activities to develop sun tracking mechanism(s) for microscale concentrated photovoltaic panels (CPV) installed at a fixed tilt (e.g., on a rooftop) that do not tip and tilt the entire PV panel to follow the sun. The proposed activities will include (1) computer design and simulation of microscale CPV optics, mechanical design and simulation of fix-tilt tracking mechanisms, and electronic and software design of control mechanisms; (2) lab prototyping of optical, mechanical, and control designs, including actual performance of fabricated optical components, proof-of-concept test of tracking mechanism and tracking accuracy, and proof-of-concept test of control loop; and (3) actual field test of microscale CPV subpanels with tracking of the sun. If successful, the technology will provide a cost-effective way of expanding CPV technology and products to places previously unavailable to CPV, such as in urban areas with many rooftops that are unsuitable for conventional CPV panels.

Panasonic will comply with applicable local, state, and federal regulations and incorporate appropriate control technologies and best management practices in all project activities. Panasonic is required, under the terms of its ARPA-E Cooperative Agreement, to submit an amended EIQ to ARPA-E identifying the location of proposed outdoor testing. Testing may only proceed after an amended NEPA determination is issued by ARPA-E.

Project activities will be conducted at existing facilities that are designed for the applicable activities, and will be conducted in accordance with applicable Federal. State_and local safety and environmental requirements.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
